

**PUBLIC NOTICE**

**DRAFT NUECES COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN  
AVAILABLE FOR PUBLIC REVIEW AND COMMENT**

The Plan is being completed through a cooperative effort of officials from Nueces County and the cities of Agua Dulce, Bishop, Corpus Christi, Driscoll, Petronila, Port Aransas, and Robstown, as well as the Port of Corpus Christi Authority.

Under the Disaster Mitigation Act of 2000, the Federal Emergency Management Agency (FEMA) requires communities to develop a mitigation plan to minimize or eliminate the long-term risk to human life and property from known hazards. Mitigation is defined by FEMA as sustained actions taken to reduce or eliminate long-term risk to people and property from hazards and their effects. Hazards that may pose a risk and potentially result in a disaster include Hurricanes, flood, drought, tornado, wildfire, extreme heat, and other high hazards.

Communities with a FEMA-approved Plan are eligible for certain grant funding under the Hazard Mitigation Assistance (HMA) program to fund critical projects such as Buyouts and Structural Elevation of repetitive flood loss structures, drainage projects, and hardening critical facilities to minimize future damage from natural disasters that affect the County planning area.

All comments received from the public will be documented and considered for inclusion in the plan. The public, area businesses and organizations located throughout the planning area are invited and encouraged to attend.
