- Assists in Dismantling grounds keeping equipment for pre-use checks.
- Cleans and removes dust, dirt, grease and waste material from grounds keeping equipment.
- Cleans work area, tools and equipment.
- Functioning in pre or post-disaster preparedness as an essential employee.
- Provides assistance to other employees to achieve maximum departmental efficiency.
- Promotes safety awareness and environmental consciousness, and complies with all applicable safety environmental procedures and regulations.
- Adhering to PCC policy and maintaining good, positive employee and customer relations and works towards a safe work environment.
