Under the general supervision of the Director of Environmental Planning & Compliance, this position monitors and ensures compliance with applicable environmental regulatory requirements (federal, state and local) for Port of Corpus Christi Authority and properties; and assists development and implementation of needed environmental management programs. The Senior Environmental Specialist:

- Conducts routine field inspections compliance audits of Port facilities, properties, and tenant facilities as necessary for ensuring environmental compliance and maintains appropriate documentation of such inspections.
- Responsible for implementation of applicable federal, state, and local agency requirements concerning environmental compliance for Port and tenant operations on Port property.
- Conducts research into federal, state, and local environmental requirements as it pertains to existing Port facilities, properties, and tenant facilities to make an applicability determination and/or develop appropriate programs and procedures for compliance purposes.
- Collect and interpret technical/analytical data, researches environmental issues with respect to regulatory criteria, and prepares documentation for appropriate distribution (internal and external).
- Promotes Port interests during spill response efforts ensuring that spills on Port property are cleaned adequately qu and appropriate documentation of such efforts. Includes after hours' spill callout on a rotating basis.
- Oversight for and responsibility for implementation and maintenance of Port's Tenant Audit Program, including conducting routine tenant audits, finding resolution on identified environmental issues, and conducting follow up audits when warranted. Also includes responsibility for settina appropriate environmental baselines at the start of new leases. Responsible for maintaining inspection

- findings and documentation of tenant compliance in GIS and Docuware.
- Responsible for development, implementation, and report of annual tenant environmental compliance through a scorecard system.
- Responsible for coordination, representation of providing interests. and relevant documentation and records during inspections and audits by agency personnel.
- Assists with development of training programs for Port users and tenants and conducting training for Port users and tenants.
- Assists with the organization and maintenance of the Port's environmental files, records, and reports, and with the Port's GIS.
- Attends various environmental conferences, seminars, meetings and events as needed to present or represent the Port's environmental compliance and stewardship efforts. **Participates** designated environmental in associations as directed to represent the Port's interests.
- Assists with the implementation of the Port's Environmental Policy throughout the Port.
- Functions in pre or post-disaster preparedness as an essential employee.

While performing duties, this position regularly requires sitting, standing, walking, speaking or hearing, using hand to finger movements; frequently required to reach and occasionally required to lift and/or move up to 30 pounds, stoop, kneel, climb, crouch, or crawl.

- Bachelor's Degree in Environmental, petroleum, or chemical engineering or physical or biological science or related field with emphasis on environmental studies.
- Ability to obtain and maintain a Transportation Worker Identification Credential (TWIC) during course of employment.

- Minimum of 10 years experience in positions requiring proficiency with the analysis and application of environmental regulations including air, storm water, waste, spill prevention and waste water.
- Skilled in the application of environmental and technical concepts
- A working knowledge of AutoCAD, Microsoft Access, Microsoft Word, Microsoft Excel, GIS application and common regional databases.
- Experience in the writing and preparation of reports; proficiency in word processing, data research, spreadsheets and database programs; or acceptable experience.
