- Performs cuts and/or joins metal parts to fabricate or repair gates, handrails, equipment stands, pipe racks, ship panels, etc., using tools such as a plasma cutter, welder, torch, chop saw grinder and other power tools.
- Experienced in pipe and plate layouts
- Proficiency in arc, mig, tig welding and soft solder techniques to join metals such as;
 malleable steel, carbon steel, stainless steel and copper joints and fittings.
- Experienced in gauge settings of oxyacetylene and argon equipment, arc welder, mig welder.
- Procures parts, materials and equipment necessary to complete jobs.
- Maintains inventory of PCCA owned tools and equipment.
- Identifies and reports needed repairs to PCCA buildings and equipment.
- Assists other crews with basic plumbing, electrical, carpentry or mechanical work to achieve maximum departmental efficiency.
- Directs and trains assigned crew in daily general preventative maintenance of facilities and building.
- Assures work area, tools and equipment are cleaned upon completion of assignments.
