

## **NOTICE OF ONLINE PUBLIC AUCTION FOR SALE OF SURPLUS PROPERTY**

The auction will begin on Thursday, June 6, 2024, at 8:00 AM CST and end Thursday, June 20, 2024, at 12:00 PM CST. Inspection will be held on Monday, June 17, 2024, from 8:00 AM CST to 12:00 PM CST at PCCA Maintenance Building, 4985 Rincon, Corpus Christi, Texas and 1:00 PM CST to 5:00 PM CST at PCCA Building, 222 Power Street, Corpus Christi, Texas. PCCA employees escorting potential buyers are not authorized to answer any questions pertaining to any vehicle, equipment or miscellaneous items offered for auction.

Bidders for this auction must register at the website and, by taking part in the bidding process, acknowledge that they fully understand the terms and conditions outlined on the site and agree to be bound thereby. The payment terms of the sale are posted on the website.

Removal shall take place between the hours of 9:00 AM CST and 3:00 PM CST on Thursday, June 27, 2024, and Friday, June 28, 2024. Buyer is responsible for all aspects of the removal of the purchased items, including loading and transportation from PCCA property. Buyer must produce proof of purchase and payment in order for PCCA to release the item. Vehicle titles and keys will not be released without proper authorization documentation. After July 7, 2024, the property ownership will revert back to the PCCA and payment thereof will be kept by the PCCA.

The PCCA reserves the right to accept or reject any or all bids. All sales will be made to the highest bidder and shall be final. All items are sold in an "as is, where is" condition, free from any guarantee or warranty. Buyer understands that additional damage may have been made to the item since the posting of the information on the auction webpage.
