

EXECUTIVE SUMMARY

Key Year to Date Highlights

- Year to date Tonnage ahead of the same period prior year by 3%.
 - Highest 2nd Quarter tonnage in the Port's history.
 - Highest 1st Half of Year tonnage in the Port's history.
- Year to date Net Operating Income (NOI) exceeds Budget by 35% and above the same period prior year by 24%.
 - Revenue 5% above Budget and 10% above of 2024.
 - Operating Expenses, excluding depreciation, are 17% lower than budget due to lower maintenance and professional services; and 4% lower than prior year due to lower maintenance expenses.
- 2025 inbound rail car movements below 2024, while outbounds are ahead of 2024 - overall decrease of 17%.
- 2025 Capital Spending slightly below budget and prior Year.

Total Tonnage


Crude Oil Tonnage


Operating Revenue
