

EXECUTIVE SUMMARY

Key Year to Date Highlights

- Year to date Tonnage slightly ahead of prior year.
- Year to date Net Operating Income (NOI) exceeds Budget by 11% and below the same period prior year by 12%.
 - Revenue 3% below Budget and 1% ahead 2023.
 - Operating Expenses, excluding depreciation, are 14% lower than budget due to lower maintenance and professional services; and 14% higher than prior year due to higher employee services, maintenance and insurance.
- 2024 inbound rail car movements are significantly above 2023, while outbounds are slightly ahead of 2023 - overall increase of 130% dominated by Agricultural movements at ADM.
- 2024 Capital Spending below budget and prior Year.

Operating Revenue and Net Operating Income








